ALL PERMIT APPLICATIONS MUST INCLUDE THE FOLLOWING:

1. Two (2) copies (at least 11" x 17") and a digital PDF of a formal, scaled plot plan of the property showing all easements and dimensions to property lines.
2. Two (2) copies (at least 11" x 17") and a digital PDF of the complete plans of the project, including framing, engineered wind bracing plans and roof plan. (The building Official is authorized to waive the submission of construction documents and other data to be prepared by a registered design professional if it is found that the documents submitted clearly show that the proposed project complies with the 2015 International Residential Codes).
3. Two (2) copies (at least 11" x 17") and a digital PDF of the engineered foundation plans, to include: both the cable details and the beam details. Must show the engineer's seal, date, signature, and location of the project.
4. Lighting Plan as per the Dark Sky Ordinance Sec. 3.09
5. A form survey will need to be at the job site and submitted to the Permitting Department to be kept with the Permit File.
6. REScheck Energy Letter available at www.energycodes.gov
7. Drainage Analysis per the City of Bulverde Stormwater Drainage Manual.
8. If property is in a Floodplain: FEMA Elevation Certificate available at www.fema.gov
9. Driveway Permit Application and all associated fees, excluding gated communities and home additions. The driveway must be completed PRIOR TO THE FINAL INSPECTION of the building project
10. Tree plot plan if any trees are being removed. A separate tree permit may be required.

SECTION 1: GENERAL PROVISIONS

1. One copy (1) of each of the above will be returned to the builder to be retained at the job site and available for all inspections.
2. No structure (including wells) can be built within the property setback.
3. No work of any kind may start until a permit is issued.
4. It is the responsibility of the contractor to contact the HOA/POA prior to beginning construction.
5. The permit may be revoked if any false statements are made herein. If revoked, all work must cease until permit is re-issued.
6. All construction waste and/or disposal services must be provided by Waste Connections www.wasteconnections.com (855) 809.2783.
7. A permit becomes null and void if work or construction authorized is not commenced within 180 days, or if construction or work is suspended or abandoned for a period of 180 days at any time after work is commenced.
8. Applicant is hereby informed that other permits may be required to fulfill local, state, and federal regulatory requirements.
9. Applicant hereby gives consent to the City Manager or his/her representative to make reasonable inspections required to verify compliance. **ALL PERMITS REQUIRE FINAL INSPECTION.**
10. Note: If a septic system is required for this project, a permit must be obtained from the Comal County Engineer's Office (phone (830) 608-2090; WWW.CCEO.ORG). A copy of the septic permit must be retained on site with the building permit.
